

## Call for Candidates for Election to World Boxing Executive Board at the Inaugural World Boxing Congress, November 2023

Dear National Federation President and General Secretary,

World Boxing is now firmly established and part of the commitments to delivering a sustainable and fit for purpose International Federation to govern Olympic style Boxing is to hold a fair, independent and transparent Inaugural Congress, including elections for the office bearer positions of the organisation.

You are cordially invited to apply or nominate candidates for the office bearing positions for World Boxing by 25 August 2023, 6pm Central European Time.

Any candidate for the World Boxing office bearer positions must be supported and submitted by their National Federation. It is important to note, for the candidature to be valid at the time of the elections the National Federation must be a Full Member or Associate Member of World Boxing at the time of the Inaugural Congress.

All candidates must comply with World Boxing Rules and Regulations including the Code of Ethics, Code of Conduct and the Rules for Candidates for Elections. These documents can be found at www.worldboxing.org.

All candidates will be vetted by an independent third-party organisation and the final list of approved candidates will be published 30 days before the actual Inaugural Congress being held. The decision on the validity of a candidate by the vetting independent thirdparty organisation is final.

The office bearing positions available for World Boxing elections are:

## President

**Three Vice Presidents** (Note: Both genders must be represented for President and Vice Presidents)

Four Executive Board Members (Note: Both genders must be represented in the Executive Board members)

**Chair Sport and Competition Committee** (Candidate must have appropriate technical experience)



**Chair Medical and Anti-Doping Committee** (Candidate must have appropriate experience)

Chair Finance and Audit Committee (Candidate must have appropriate experience)

A candidate can apply for a maximum of two (2) office bearer positions.

Application of Candidates must be sent by the National Federation to <u>simon.toulson@worldboxing.org</u> with a short CV (No more than two (2) pages) and a motivational letter (no more than two (2) pages) outlining their vision for World Boxing and what attributes the candidate can bring to the position should they be elected. **Applications for Candidates for World Boxing office bearer positions will close 6pm Central European Time on 25 August 2023.** 

In addition to the Elections, National Federations are invited to send nominations for candidates with appropriate experience to be members of the Committees of World Boxing.

Committee member nominations are for:

- Sport and Competition Committee
- Medical and Anti-doping Committee
- Finance and Audit Committee

A short CV (no more than two (2) pages should be provided for each candidate to <u>simon.toulson@worldboxing.org</u>. The World Boxing Committee Members will be chosen by the World Boxing Executive Board immediately after the Inaugural Congress. The deadline for candidates for World Boxing Committee Members is 6pm Central European time on 25 September 2023.

Finally, as per the World Boxing Statutes, National Federations can submit proposals for changes, additions or amendments to the existing Statutes and Rules and Regulations. The deadline for any proposals from the National Federations is 6pm Central European Time on 25 August 2023.
