3. COMPETITION RULES & FORMAT

This event will be conducted in accordance with the actual World Boxing Competition Rules.

Event category	2025 World Boxing Challenge
Age category	Elite, born from 1 January 1985 to 31 December 2006
Men's weight categories	50kg, 55kg, 60kg, 65kg, 70kg, 75kg, 80kg, 85kg, 90kg, +90kg.
Women's weight categories	48kg, 51kg, 54kg, 57kg, 60kg, 65kg, 70kg, 75kg, 80kg, +80kg.
Draw sizes and composition	Max 16 boxers per weight category, as limited by the number of competition days. Max 1 boxers per NF, per weight category
Number of rings	One ring, maximum 2 rings based on the number of participants
Scoring and timing	Swiss Timing
Boxing equipment	Sting gloves will be provided by the LOC, headguards will NOT be provided by the LOC
Hand wrapping	Velcro bandages must be used by all participating boxers. Bandages will NOT be provided by the LOC, but must comply with World Boxing Competition Rules
Technical Officials	World Boxing certified
Boxing Entries Check	Mandatory for inclusion into the draw, appointment set prior to arrival

5. ENTRY PROCESS

It is required that respective participating National Federations confirm the technical and medical standard of the boxers and other Team Members. Participating National Federations are also responsible for submitting the personal data on behalf of each member of their Team, and for ensuring that the personal information provided during the entry process is accurate.

At this time, the entry process for Teams is completed via email, as specified in the table below: To guarantee your accommodation and entries we need to receive your preliminary entries (Long list/Entry by number of at least which gender and weight category and number of the supporting team are going to participate) till 31st March 2025 latest.

Entering reserve boxers is strongly encouraged to allow for substitutions after the entry deadline prior to the Boxing Entries Check without penalties.

It is **mandatory** for all participating National Federations with three or more participating boxers to delegate a World Boxing certified Referee and Judge as a part of their Teams. Referee and Judges are subject to confirmation by World Boxing. **World Boxing may request that another R&J is delegated for this event by the participating National Federation.**

Participating National Federations that fail to delegate an appropriately certified R&J for a Team with three or more boxers will be subject to a EUR 500 penalty. This penalty must be paid prior to the Boxing Entries Check.

Withdrawals after the final entry deadline will not be refunded.

Each participating National Federation can enter the following number of Team Members to accompany the boxers:

It is the responsibility of participating National Federations to ensure that all Team Members are qualified to perform their duties.

5.1. Boxing Entries Check

The Boxing Entries check is the final part of the event entry process. World Boxing and the LOC will inform Teams of their exact appointment time prior to the event as well as it will be displayed on the Team information board.

The Boxing Entries Check is mandatory for all Teams, and teams should make all necessary arrangements to arrive timely for their respective appointment.

Each Team may appoint a maximum of two people to attend its Boxing Entries Check (e.g. Team Leader and the Team Doctor).

In order to be cleared for the competition, Teams must provide the following documents for each boxer, signed and completed as required:

- Copy of passport
- Record Book (with annual medical examination completed within the previous 12 months)
- Medical Certificate issued within the previous three months, signed by the National Federation doctor
- Declaration of Non-Pregnancy Form (women boxers only), signed by the boxer/legal guardian
- Uniforms (red and blue) per World Boxing Competition Rules

To complete the Boxing Entries process and receive accreditations, Teams must have fully settled their accommodation costs with the LOC.

Important: Failure to attend the Boxing Entries Check per scheduled appointment by any Team will lead to the exclusion of the entire Team from taking part in the event.

6. VISA & ENTRY TO THE HOST COUNTRY

LOC will provide assistance to participating National Federations requiring Visas but cannot guarantee their acquisition.

For information and visa support letters, please complete visa information form and email via svata.zacek@centrum.cz. The deadline to submit requests for visa support letters is 21 March 2025 (23:59 CET).

Passports of all Championships participants must be valid for at least six months from the date of arrival and must contain blank page(s) for visa(s) and stamps.

It is the responsibility of participating National Federations to ensure that their Teams respect the conditions of stay defined by the Government of the country hosting the event. If any participant does not respect these conditions, any costs arising will be borne by the respective National Federation.

7. INTERNATIONAL TRANSPORTATION

The designated airport for arrival and departure of Teams is **Prague International Airport (PRG)**.

All Teams must submit their arrival and departure details to the LOC via svata.zacek@centrum.cz by 30 May 2025 (23:59 CET).

8. GROUND TRANSPORTATION

The LOC will provide airport transfers and ground transportation for Teams during the event period between the training and competition venues and the delegation hotels. This service is only offered on the days when the delegations are booked in an official hotel through the LOC. If delegations are using an unofficial hotel or an official hotel, not reserved through the LOC, they are not allowed to use the official event transportation.

Additional transportation costs will apply when airport transfers or any other transportation is required outside of event days and costings will be sought on request.

Guidance information and timetables will be displayed on event information boards in the lobby of the Event Hotels.

10. ACCOMMODATION

All Teams must submit their accommodation request and rooming list to the LOC via svata.zacek@centrum.cz by 31 March 2025. (23:59 CET).

Any damage to Event Hotel property resulting from the stay of a Team will be charged to the respective National Federation and must be paid in full. Delegations are kindly requested not to dry clothing or have training sessions in the corridors of the Event Hotels.

Only accredited Event participants will be allowed to stay in the Event Hotels.

10.2. Payment terms

All Teams must cover costs of their accommodation for the entire Event Period. Accreditations will not be issued until accommodation has been paid in full to the LOC.

Bank transfer payment is accepted and must be completed **by 30 May 2025**,

Please, request an official invoice from the LOC before making the payment to settle the total amount.

11. IMAGE RIGHTS & VIDEO RECORDING

The LOC will film the event for broadcast, promotional videos and official event photographers will take still images of boxers before and during the event. All training sessions will be open to the accredited media unless a Team specifically requests otherwise. By participating in the event, each Team Member agrees to release his/her image rights to World Boxing and the LOC.

Video recording of bouts by an NF for broadcasting purposes of any kind (including social media) will not be allowed.

National Federations may be allowed to record bouts of their boxers using only one camera per ring, exclusively for technical purposes. Specific location in the venue will be reserved for this purpose. Each National Federation must submit a signed copy of Video Recording Disclaimer at the Technical Meeting to World Boxing Competition Manager.

12. MEDICAL SERVICES

The LOC will provide first aid during the entire event period to any participant who suffers from a sports injury contracted during the event.

13. ANTI-DOPING

Doping control will be conducted in accordance with World Boxing Anti-Doping Rules and World Anti-Doping Code. According to WADA regulations, blood testing may be conducted during World Boxing Competitions.

14. INSURANCE

All accredited participants must have their own travel, medical, repatriation and liability insurance covering the entire event and travel period. Health Insurance for all delegation members is a duty and responsibility of the respective National Federation in every World Boxing event.
