We could not hope for a better place to hold our inaugural World Boxing Championships and I would like to thank GB Boxing and England Boxing and all of their partners for bidding to host this prestigious event. The partners have established a highly skilled Local Organising Committee (LOC), made up of people with longstanding experience of staging major global sporting events and I am certain they will deliver a first-class experience for boxers, coaches, officials, team delegations and spectators.

I look forward to welcoming you all to Liverpool in September and have no doubt that it will be a fantastic opportunity for all of our male and female boxers to demonstrate their skills and qualities and provide a platform to showcase the values of sportsmanship, fairness and sporting integrity that are central to World Boxing's outlook and vision for the sport.



This event will be conducted in accordance with the actual World Boxing Competition Rules.

5. ENTRY PROCESS

It is required that respective participating National Federations confirm the technical and medical standard of the boxers and other Team Members. Participating National Federations are also responsible for submitting the personal data on behalf of each member of their Team, and for ensuring that the personal information provided during the entry process is accurate.

NFs will be requested to enter the World Boxing Championships by submitting a Phase 1 Entry by Number & Accommodation Request Form. Phase 2 Entry by Name will request full information via the Games Management System (GMS). Rooming lists and transport information will be requested separately. Data will be held in accordance with the event Privacy Policy which can be viewed on our website www.worldboxingliverpool.com

Registering reserve boxers is strongly encouraged to allow for substitutions after the entry deadline prior to the Sport Entries Check without penalties.

5.1. Accompanying Team Members

The total number of Team Officials that may be accredited per NF depends on the number of competing Boxers. Each Team Delegation may include the following accredited Team Officials:

- 1 Team Manager
- 1 Team Doctor (must be registered within their NOC/NF)
- 1 Physiotherapist
- 1 Dietitian/Nutritionist
- Coaches with ringside access:

 1-3 Boxers: Up to 3 Coaches 4-8 Boxers: Up to 6 Coaches

9-20 Boxers: Up to 8 Coaches

It is the responsibility of participating National Federations to ensure that all Team Members are qualified to perform their duties.





















5.2. Sport Entries Check

The Sport Entries check is the final part of the event entry process and it will take place on 02 September at the Leonardo Hotel. World Boxing and the LOC will inform Teams of their exact appointment time prior to the event as well as it will be displayed on the Team information board.

The Sport Entries Check is mandatory for all Teams, and teams should make all necessary arrangements to arrive on time for their respective appointment.

Each Team may appoint a maximum of two people to attend its Sport Entries check (e.g. Team Manager and the Team Doctor).

In order to be cleared for the competition, Teams must provide the following documents for each boxer, signed and completed as required:

- Copy of Passport
- 0 Record Book (with annual medical examination completed within the previous 12 months)
- 0 Medical Certificate issued within the previous three months, signed by the National Federation Doctor
- 0 Declaration of Non-Pregnancy Form (women boxers only), signed by the boxer/legal guardian
- 0 Uniforms (red and blue) per World Boxing Competition Rules
- Ŏ Signed Conditions of Participation Form for each Team Member (If form not previously submitted
- online)
- Signed World Boxing Code of Conduct (If form not previously submitted online)

To complete the Sport Entries process and receive accreditations, Teams must have fully settled their accommodation costs with the LOC.

Important: Failure to attend the Sport Entries Check per scheduled appointment by any Team will lead to the exclusion of the entire Team from taking part in the event with all accommodation and fees payable to the LOC forfeit.

6. VISA & ENTRY TO THE HOST COUNTRY

LOC will provide assistance to participating Teams requiring Visas but cannot guarantee their acquisition.

For information and visa support letters, please complete registration via the GMS and email BOXING@mlsqb.co. The deadline to submit requests for visa support letters is 09 June 2025. Visa requirements to the UK are lengthy and the standard processing time will take at least THREE WORKING WEEKS from when you submit your biometric data (not from the start of the visa application). Please see visa information and how to apply in the appendix. Please complete all visa paperwork and biometric data by 01 August 2025 at the latest.

Passports of all Championships participants must be valid for at least six months from the date of arrival and must contain blank page(s) for visa(s) and stamps.

Please note, as of March 2025, the Electronic Travel Authorisation (ETA) was introduced as a new requirement for visitors who currently do not need a visa for short stays to the UK, or who do not already have a UK immigration status prior to travelling. An ETA can be applied for online and will be electronically linked to the passport, giving you permission to travel to the UK. An ETA will last for two years or until the expiry date of your passport (whichever is sooner).





















You will not need an ETA if you have either a visa, a permission to live/work/study in the UK or a British/Irish Passport. Further Information: https://www.gov.uk/guidance/apply-for-an-electronic-travel-authorisation-eta It is the responsibility of participating National Federations to ensure that their Team respect the conditions of stay defined by the Government of the country hosting the event. If any participant does not respect these conditions, any costs arising will be borne by the respective National Federation.

7. INTERNATIONAL TRANSPORTATION

The designated airport for arrival and departure of Teams are **Manchester airport (MAN)** and **Liverpool John Lennon Airport (LPL)**.

All Teams must submit their arrival and departure details to the LOC via boxing@cseplc.com by 01 August 2025 (23:59 CET).

Official arrival transport will be available on 01 September, 02 and 11 September 2025. Official departure transport is available on 15 September 2025.

8. GROUND TRANSPORTATION

The LOC will provide airport transfers to official hotels for Teams on official arrival and departure days. Transport from designated hotels to the competition venue will not be provided as all hotels are within short walking distance. If delegations are using an unofficial hotel or an official hotel, not reserved through the LOC, they are not allowed to use the official event transportation.

Additional transportation costs will apply when airport transfers or any other transportation is required outside of event days and costings will be sought on request.

Guidance information and timetables will be displayed on event information boards in the lobby of the Event Hotel.

IMPORTANT NOTICE

After the Phase 1 Entry Deadline all accommodation will be released by the LOC and may not be available for nations that have not made any bookings. It is important to note that All Nations will be committed to the room bookings they make at the Phase 1 Entry Deadline. We advise you to book your minimum requirement and liaise with the LOC on any increases that are required should your numbers change following the Phase 1 Entry. Should World Boxing change entry criteria that does not allow a selected Boxer to attend refunds will be made.

Any damage to Event Hotel property resulting from the stay of a Team will be charged to the respective National Federation and must be paid in full. Delegations are kindly requested not to dry clothing or have training sessions in the corridors of the Event Hotels.

Only accredited Event participants will be allowed to stay in the Event Hotels. Teams are being offered a 13-night package for their stay in Liverpool, rates are full board and include 3 meals per day and transportation between hotels and official airports on official travel days. Please be aware, all hotels and public spaces in the UK are non-smoking.

All meals for registered attendees will be served in their respective hotel and delegation members will only be permitted to eat in the hotel they are staying in for all meals.

The 13-night package is based on arrival Tuesday 02 September and departure Monday 15 September.

10.1. Payment terms

All Teams must cover costs of their accommodation for the entire Event Period. Accreditations will not be issued until accommodation has been paid in full to the LOC.

Bank transfer payment is accepted, and a 20% deposit payment is due for payment by **30 May 2025**. Final balance owing to be paid in full no later than **04 July 2025**. All payments must be received in **POUNDS STERLING (GBP)**.

Teams are responsible for covering any foreign currency or bank charges in relation to their payment.

Note that all costs are committed at the Phase 1 Entry Deadline.
















11. IMAGE RIGHTS & VIDEO RECORDING

The LOC will film the event for broadcast, promotional videos and official event photographers will take still images of boxers before and during the event. All training sessions will be open to the accredited media unless a Team specifically requests otherwise. By participating in the event, each Team Member agrees to release his/her image rights to World Boxing and the LOC.

Video recording of bouts by for broadcasting purposes of any kind (including social media) will not be allowed.

National Federations may only record bouts of their boxers using one camera per ring if for technical purposes. Specific location in the venue will be reserved for this purpose. Each National Federation must submit a signed copy of Video Recording Disclaimer at the Technical Meeting to World Boxing Competition Manager.

12. MEDICAL SERVICES

The LOC will provide first aid during the entire event period to any participant who suffers from a sports injury contracted during the event.

13. ANTI-DOPING

Doping control will be conducted in accordance with World Boxing Anti-Doping Rules and World Anti-Doping Code. According to WADA regulations, blood testing may be conducted during World Boxing Competitions.

14. INSURANCE

All accredited participants must have their own travel, medical, repatriation and liability insurance covering the entire event and travel period.

15. OTHER PRACTICAL INFO
