- Demonstrating strong interest in hosting major international World Boxing events in Germany, building on the successful organization of the 2017 AIBA World Championships in Hamburg and offering world-class stages for our athletes.

I believe my long-standing experience as Sports Director and Secretary General of the German Boxing Association, my leadership in international commissions, and my proven commitment within World Boxing make me well-suited to continue serving on the Executive Board.
